Eight samples of each product will be used in the contest, and it would be prudent to have several extra samples from which to make your selections for the competition.

- All samples must be shipped the week of April 3rd, so please communicate with your vendors.
- Please ensure all samples shipped are labeled "Collegiate Contest" + the product category.
